# VOTE EXPLANATIONS 2015 – HOUSE

## **HB 591** – New Hampshire House Roll Call #43

### **AFP-NH Position:** *Nay*

**Analysis:** This legislation reversed the 23% increase in the gas and diesel tax passed in 2014.

Motion to kill passed 243-108

## **HB 208** – New Hampshire House Roll Call #45

### **AFP-NH Position:** *Yea*

**Analysis:** This bill rebated all funds collected by the Regional Greenhouse Gas Initiative (RGGI) back to electric ratepayers. Passed the House 201-154. Failed in committee of conference.

## **CACR 1** – New Hampshire House Roll Call #53

### **AFP-NH Position:** *Nay*

**Analysis:** This constitutional amendment would require a 3/5th supermajority in the New Hampshire House and Senate to raise taxes or fees. Motion to kill the constitutional amendment passed 226-128.

## **HB 673** – New Hampshire House Roll Call #76

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would establish a general sales tax across New Hampshire. Motion to kill passed 355-13.

## **HB 548** – New Hampshire House Roll Call #83

### **AFP-NH Position:** *Yea*

**Analysis:** This legislation would establish a state-based exchange under the Affordable Care Act.

Motion to kill passed 237-131.

## **HB 658** – New Hampshire House Roll Call #102

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would implement a Right to Work law in New Hampshire. Passed the House 149-146. Failed in the Senate.

## **HB 563** – New Hampshire House Roll Call #104

### **AFP-NH Position:** *Yea*

**Analysis:** This bill expands school choice by indexing charter school funding to inflation and by increasing funding for existing charter schools. Passed the House 222-116. Passed, but then tabled, in the Senate. Included in state budget.

## **HB 684** – New Hampshire House Roll Call #113

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would increase the minimum wage in New Hampshire. Motion to kill passed 198-145.

## **HB 2** – New Hampshire House Roll Call #135

### **AFP-NH Position:** *Yea*

**Analysis:** This portion of the state budget represents the “trailer bill” – statutory changes necessary to allow budget to balance.

Passed the House 194-179. Governor’s veto overridden to become law.

## **HB 1** – New Hampshire House Roll Call #143

### **AFP-NH Position:** *Yea*

**Analysis:** This portion of the state budget represents the actual funding authorization, including individual line items.

Passed the House 212-161. Governor’s veto overridden to become law.

## **SB 101** – New Hampshire House Roll Call #145

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would ensure that no school district would be forced to implement Common Core education standards. Passed in the House 202-138. Vetoed by Governor.

## **HB 2** – New Hampshire House Roll Call #178

### **AFP-NH Position:** *Yea*

**Analysis:** This committee of conference version of HB 2 includes reductions to the business profits tax and business enterprise tax, as included in the Senate budget. Passed in the House 196-164. Governor’s veto overridden to become law.

## **SB 550** – New Hampshire House Roll Call #181

### **AFP-NH Position:** *Yea*

**Analysis:** The committee of conference report would protect closely-held LLCs from being subject to having the business profits tax from capitalization.

Passed in the House 202-145. Vetoed by the Governor.

## **SB 204** – New Hampshire Senate Roll Call #5

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would repeal the education tax credit scholarship program.  
Motion to kill passed 14-10.

## **SB 107** – New Hampshire Senate Roll Call #10

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would implement a Right to Work law in New Hampshire.  
Failed in the Senate 12-12.

## **SB 1** – New Hampshire Senate Roll Call #13

### **AFP-NH Position:** *Yea*

**Analysis:** This bill reduces the business profits tax in New Hampshire.  
Passed the Senate 14-10, then tabled on 3rd reading.

## **SB 2** – New Hampshire Senate Roll Call #14

### **AFP-NH Position:** *Yea*

**Analysis:** This bill reduces the business enterprise tax in New Hampshire.  
Passed the Senate 14-10, then tabled on 3rd reading.

## **HB 261** – New Hampshire Senate Roll Call #23

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would increase the minimum wage in New Hampshire.  
Motion to kill passed 14-10.

## **CACR 5** – New Hampshire Senate Roll Call #40

### **AFP-NH Position:** *Yea*

**Analysis:** The constitutional amendment would ensure that taxpayers have standing to take legal action against government.  
Passed in the Senate 24-0. Retained in the House.

## **HB 563** – New Hampshire Senate Roll Call #61

### **AFP-NH Position:** *Yea*

**Analysis:** This bill expands school choice by indexing charter school funding to inflation and by increasing funding for existing charter schools.

Passed the Senate 14-10, then tabled on 3rd reading.

## HB 208 amendment – New Hampshire Senate Roll Call #97

### **AFP-NH Position:** *Nay*

**Analysis:** This amendment would, instead of rebating funds from the Regional Greenhouse Gas Initiative (RGGI) to the ratepayers, would raise residential electric rates for additional RGGI spending.  
Amendment passed 14-10.

## HB 550 – New Hampshire Senate Roll Call #100

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would protect closely-held LLCs from being subject to having the business profits tax from capitalization.  
Passed the Senate 14-10. Vetoed by the Governor.

## **SB 101** – New Hampshire Senate Roll Call #110

### **AFP-NH Position:** *Yea*

**Analysis:** This bill would ensure that no school district would be forced to implement Common Core education standards.  
Passed the Senate 13-11. Vetoed by the Governor.
