1. To Vote: Completely fill in the oval to the right of your choice like this .
 For each office vote for up to the number of candidates stated in the sentences:
 "Vote for not more than 1;" or "Vote for up to X;" "X will be elected." If you vote
 for more than the stated number of candidates, your vote for that office will not
 be counted.

2. To Vote by Write-In: To vote for a person whose name is not printed on the
 ballot, write the name of the person in the "write-in" space and completely fill in
 the oval to the right of the "write-in" space like this .

2024 CONSTITUTIONAL AMENDMENT QUESTION
Constitutional Amendment Proposed by the 2023 General Court

1. "Are you in favor of amending article 78 of the second part of the constitution to read as follows: [Art.] 78. [Judges and Sheriffs, when Disqualified by Age.] No person shall hold the office of sheriff of any county, after the person has attained the age of seventy years. No person shall hold the office of judge of any court after the person has attained the age of seventy-five years." (Passed by the N.H. House 321 Yes 27 No; Passed by the Senate 22 Yes 1 No) CACR 6
